Sub: Fighting between two Students in the campus in Yamuna Block

Sir

This is to inform you that the following students were reported involved in fighting inside the class room today during first period in Yamuna Block. The list of the involved students is as follow:

1. Mr. Sumit Verma B.Tech 2nd Yr AI&DS
2. Mr. Abhijit Alone B.Tech 2nd Yr AI&DS

An enquiry was conducted by Mr. Sunit Mishra , Astt Prof (CSE) & Member Proctorial Board , Ms. Ayushi Patel, Astt Prof (CSE) and Mr Kuldeep Katiyar Astt Prof (CSE). During enquiry, the following points were acknowledged:

1. There was fighting with abusing between Mr. Sumit Verma and Mr. Abhijit Alone. Initially both the students started exchanging heated argument for sitting in the class in Yamuna block room no. 102.
2. During the class , Ms Ayushi Astt Prof (CSE) warned both the students to sit properly and maintain peace and silence.
4. After first period of class, there was fighting between both the students. Injury was received by Mr. Abhijit Alone by some glass bottle thrown by Mr Sumit Verma . Mr. Abhijit Alone was sent to hospital for first aid later on.
5. During enquiry Mr. Abhijit Alone accepted that he had slapped initially Mr Sumit Verma and thereafter Mr Sumit Verma threw a glass bottle towards Mr. Abhijit Alone.


Recommendation of punishment:


The office of the chief proctor recommends the following actions for their act of indiscipline:


Mr. Abhijit Alone should be suspended from attending the classes up to 15 May 2024 and Mr Sumit Verma should be suspended from attending class the classes till further order.







Recommendation of punishment:



- c. Affidavits to be submitted from their parents regarding such incident not be repeated in future.



Sir

This has reference as produced by students as listed below against the incident took place on 04/10/2021 out side the campus at around 5:30 pm. There was an exchange of hot talks followed by slapping between some outside people and the students as mentioned as below.

A. Name of the students involved and their written statements: (As attached)

1. Avinash Singh (B. Com 3rd Year).
2. Harsh Singh (B B A 2nd Year)
3. Pradeep Tiwari (B. Tech. 3rd yr CSE)

B. Observations and Findings:

1. On the basis of interrogation and investigation made by enquiry committee, it is concluded that the students S. No. 1 to S. No. 3, were moving outside of the campus with some unknown outsiders . Avinash Singh (B. Com 3rd Year) and Harsh Singh (B B A 2nd Year) were found to be involved in hot talks with mishandling with Pradeep Tiwari (B. Tech. 3rd yr CSE) . This incident took approximately for 15 minutes around 5:30 pm. On further enquiry, it was known that there was a matter of money investment of Rs 2000/- from Avinash Singh (B. Com 3rd Year) in an company as suggested by Pradeep Tiwari (B. Tech. 3rd yr CSE) which could not be recovered and lost further. Avinash Singh (B. Com 3rd Year) was pressurizing continuously Pradeep Tiwari (B. Tech. 3rd yr CSE) for the recovery of same amount.

2. Avinash Singh (B. Com 3rd Year) was also found to be involved in hot talks followed by slapping twice an outside boy of age around 17 years on 11/09/2021 .
